1. I purchased (Rego EOY42K) Vin- 6H8VTK69FYL619829, on ----- from the \_\_\_\_\_ Auction @ Pickles Auctions Pty. Limited (Via Pickles Live) in Sunshine, Melbourne.
2. I acknowledge that prior to the sale, the Auctioneer made various disclosures in its marketing material regarding the odometer reading of the Vehicle.
3. I acknowledge that the Auctioneer disclosed that the Vehicle I purchased displayed an odometer reading that indicated that the odometer had been tampered with and that the odometer reading at the time of sale was not true and accurate.
4. I acknowledge that the Auctioneer disclosed that the last confirmed odometer reading was Unknown and that the actual number of kilometres travelled by the Vehicle is estimated to be in excess of 500,000 kilometres but cannot be confirmed or verified as the true odometer reading is unknown. I understood this to mean that the Vehicle had travelled significantly more kilometres than what was displayed on the odometer.
5. I purchased the Vehicle with full knowledge that the odometer was tampered with and the existence of the odometer discrepancy.
6. I acknowledge, accept and covenant that in the event that I attempt to resell the Vehicle I am required to disclose that the odometer has been tampered with and the existence of the odometer discrepancy to a prospective buyer prior to effecting a sale.

I understand that a person who intentionally makes a false statement in a statutory declaration is guilty of an offence under section 11 of the *Statutory Declarations Act 1959*, and I believe that the statements in this declaration are true in every particular.

*Note 1* A person who intentionally makes a false statement in a statutory declaration is guilty of an offence, the punishment for which is imprisonment for a term of 4 years — see section 11 of the *Statutory Declarations Act 1959*.

*Note 2* Chapter 2 of the *Criminal Code* applies to all offences against the *Statutory Declarations Act 1959* — see section 5A of the *Statutory Declarations Act 1959*.

**A statutory declaration under the *Statutory Declarations Act 1959* may be made before—**

(1) a person who is currently licensed or registered under a law to practise in one of the following occupations:

Chiropractor	Dentist	Legal practitioner
Medical practitioner	Nurse	Optometrist
Patent attorney	Pharmacist	Physiotherapist
Psychologist	Trade marks attorney	Veterinary surgeon

(2) a person who is enrolled on the roll of the Supreme Court of a State or Territory, or the High Court of Australia, as a legal practitioner (however described); or

(3) a person who is in the following list:

Agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public  
Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the *Consular Fees Act 1955*)  
Bailliff

Bank officer with 5 or more continuous years of service  
Building society officer with 5 or more years of continuous service  
Chief executive officer of a Commonwealth court  
Clerk of a court

- (d) a local government authority of a State or Territory

Minister of religion registered under Subdivision A of Division 1 of Part IV of the *Marriage Act 1961*

Notary public

Permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office supplying postal services to the public

Permanent employee of:

- (a) the Commonwealth or a Commonwealth authority; or
  - (b) a State or Territory or a State or Territory authority; or
  - (c) a local government authority;
- with 5 or more years of continuous service who is not specified in another item in this list
